# L1SKTTT TRAINER TRAINING - 4.5 HOURS

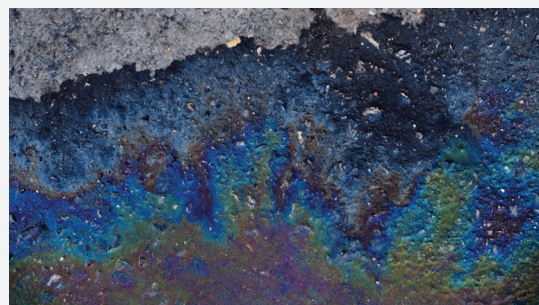

- Reporting and analysis.



- A pass/fail questionnaire will be presented as conclusion. A 70% pass will be required.
- Attendees will be expected to actively participate in the course work and will be required to prepare and make a contribution to a 30min presentation of the topics by their peer group.

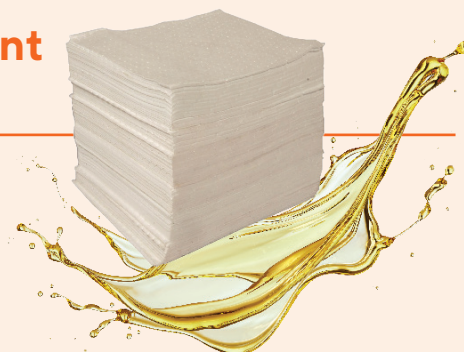
